Liability Waiver and Release

1. General Information.

The Des Moines Rehabbers Club (“DSMRC”) activities focus on construction and renovation. Construction and renovation related activities are inherently dangerous. DSMRC event participants must recognize the potential for injury to themselves which may result from participating in DSMRC activities and meetings. The DSMRC intends that participants and members expressly assume all risks and liability for any injuries, loss or damages in connection with DSMRC activities.

This Liability Waiver affects all rights in connection with participation in all activities sponsored or supervised by the DSMRC.

2. Liability Waiver and Release.

In consideration of my enjoyment, education and participation in DSMRC activities, I _____, the undersigned, hereby release, waive, and discharge from all loss or damage, injuries (whether caused by intentional, negligent, or reckless conduct), claims, and lawsuits suffered or commenced by me, my heirs, successors assigns personal representative in connection with or arising out of or touching with DSMRC activities and meetings.

I agree and covenant not to sue the DSMRC, its partners, cooperating landowners, members, coordinators, sponsors, event participants and volunteers, and any other persons (hereinafter referred to as “RELEASEES”) for any loss or damages, injuries, claims or demands, in connection with or caused by my own negligence or DSMRC’s negligence. I further agree to indemnify and hold harmless RELEASEES for any loss or claim against RELEASEES arising out of or in connection with my conduct related to DSMRC activities or meetings.

I further release and discharge DSMRC from any claim which arises or may hereafter arise in connection with any first aid, treatment, or services rendered in connection with DSMRC activities. Accordingly, I authorize DSMRC to act, in its best judgment, on my behalf in cases of emergency.

3. Release.

I understand that photographs, videos, audio recordings of my likeness (hereinafter referred to as “Personal Media”) may be taken and used during DSMRC activities. I hereby grant and convey unto DSMRC all rights, title and interest in all Personal Media prepared by DSMRC during any activities with DSMRC including, but not limited to, any donations, proceeds, or other benefits derived from such Personal Media.

4. General Provisions.

I further agree that:

- The invalidity or unenforceability of any provision of this Liability Waiver and Release shall not affect or impair the validity of any other provision.
- Words and phrases herein, including acknowledgments hereof, shall be construed as in the singular or plural number, and as masculine, feminine or neutral gender, according to the context.
- The paragraph headings are for convenience only and shall not limit or affect the terms of this Liability Waiver and Release or be considered in the application or meaning of its terms.
- This Liability Waiver and Release shall be construed in accordance with the laws of the State of Iowa.
- This writing contains the entire agreement of the parties, integrates all the terms and conditions mentioned in or incidental to this Liability Waiver and Release and supersedes all prior negotiations and writings.
